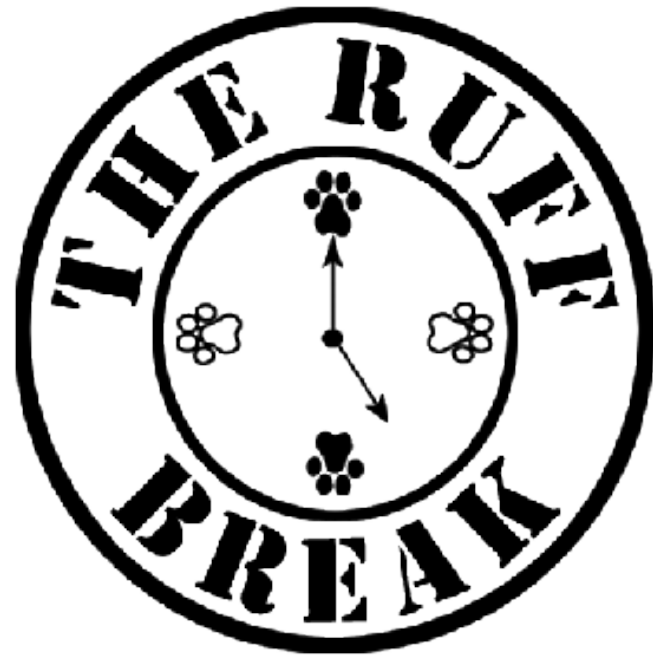

Emergency / Natural Disaster Preparedness Recommendations

In order for Ruff Break to be able to provide optimal care and safety for your pet/s during an emergency or natural disaster, we recommend the following preparatory actions:

- Hide a house key somewhere on your property or provide a copy of the key to a neighbor/friend within short walking distance that could get to your pet/s if it becomes physically impossible for Ruff Break to get there.

Location of hidden house key or name and phone number of neighbor/friend with key:

- Make sure **identification tags** are up to date and securely fastened to your pet's collar. If your pet gets lost, his/her tag is a ticket home.
- Make sure you have a **secure pet carrier**, leash or harness for your pet so that if he panics, he/she can't escape. It is a good idea to attach your pet's identification information to the carrier as well.
- Put together a "**pet survival kit**" with pet food, bottled water, medications, veterinary records, food dishes, first aid kit, blanket, (cats) litter/pan, can opener, and any other necessary other supplies with you in case they're not available later.

I will assume full responsibility for the payment and/or reimbursement for any and all veterinary services rendered, including but not limited to diagnosis, treatment, grooming, medical supplies, and boarding. Such payments will be made within 14 days of the initial incident. I also agree to be responsible for all Special Service fees assessed by Ruff Break for emergency transportation, care, supervision, or hiring of emergency caregivers, and will pay such fees within 14 days of each incident.

Ruff Break Release Form

In the case of an emergency, inclement weather, or a natural disaster I authorize Ruff Break to use their reasonable judgment for the care and well being of my pet(s) and/or house.

I understand that Ruff Break can terminate this contract if my pet becomes a threat to the safety or health of Ruff Break due to aggressive behavior. I entrust Ruff Break to contact me in any and all cases if this threat should arise. In the case that Ruff Break cannot reach me, I authorize Ruff Break to place my pet(s) in a licensed kennel with all charges arising there from to be paid by myself. Ruff Break reserves the right to refuse service to any client, at any time, for any reason.

I attest that all of the above information is true to the best of my knowledge. If anything changes from what is listed above I will inform Ruff Break before the next service is scheduled to begin.

This signed document gives Ruff Break (and their representatives) authorization to enter the above listed address as needed to perform the necessary care as outlined in this contract. I authorize this contract to be valid approval for services so as to permit Ruff Break to accept all future telephone, online, mail or email reservations for Ruff Break services without additional signed contracts or written authorizations.
